

- 1. Please look over the PDF copy of your main trust (approx. 20pgs) to make sure all spelling of your name, co-trustee names and beneficiary names are correct.
- 2. Open the certificate of trust and check for correct names and addresses on this document. (This document is required by the State of Texas to have current addresses on it. You will receive this document in word format so you can make changes easily on your time frame.)

A little about the items you are receiving...

Main Trust (PDF):

- Multi-generation usually run approx. 20 pgs. and depends on how many trustees you start with, the length may vary.
- When you purchase a class 3 item from a dealer (form 4) or when you fill out a form 1, a copy of this must accompany the forms to the ATF.
 - There are a few signature blocks for you to sign, one on page 17, two on page 18, and the very last page which should be your schedule A.
 - *** all signatures that require a notary must be complete before forms can be sent to the ATF.
 - o Make sure to rescan in the future as documents are added to the trust.

<u>Certificate of Trust</u> (WORD):

- This document is a short version of your main trust.
- You should carry a copy of this and the tax stamp for the item that you are carrying.
- This is NOT the form that the ATF would like to see when submitting a form 1 or 4.
- You will receive this form in Word so you may make address changes at will.
 - o If you are not comfortable changing the address or addresses yourself, you may email us, and we will help you with changes in a few business days.

Assignment of Property Form (WORD):

- This form is used to for addition of other items or personal property.
 - O You may use this form to add your NFA items, in addition to other items like regular guns, jewelry, cars, etc...

- We suggest you not add real property (AKA Real Estate) to this trust. For questions email us.
- O You can make as many cells as you need to add inventory.
- DO NOT send this form to the ATF. The ATF only requires the schedule A, which is the final page to your trust.

- Use this form to add trustees in the future
- Change John Doe's name to the name of the individual you are adding.
- Make sure to change all areas in yellow to relfect the information required.
 - o If you are having this form notarized in another state, make sure the information reflects that.
- Attach the originals to the main trust and make a copy and attach to the certificate of trust.

- **Keep your originals in a safe place**, and together.
- ❖ Keep a copy of all files on a flash drive for convenience.
- ❖ You can make a second copy of your flash drive (because things fail...)
